#### COVE MEETING MINUTES



The Construction Oversight and Value Engineering Committee (COVE) monthly meeting convened on Thursday, September 19, 2019 at 8:05 a.m., at Facilities Services, 6501 Magic Way, Bldg. 200, Orlando, Florida 32809.

**COVE Members in Attendance**: Ksenia Merck, Pat Knipe, James Knapp, and Douglas Kelly.

#### Call to Order:

A quorum was established and Chairman Ksenia Merck called the meeting to order at 8:05 a.m.

#### Chairman Comments

Ksenia Merck thanked the OCPS team for the tour of Pershing School that was conducted in August.

Superintendent Barbara Jenkins announced that Vice-Chairman Pat Knipe will be inducted into the Mid-Florida Business Junior Achievement Hall of Fame on Thursday, September 26, 2019 at the Rosen Centre Hotel.

#### Approval of Minutes

The minutes from June 20, 2019 were presented and approved unanimously by the committee.

#### Departmental Reports

#### > Finance Report

Judith Padres reported that since our last report, the School Board approved the new adopted budget on September 10, 2019. She mentioned that there were three (3) new relief schools added to the list to be completed in 2021(Site 43-E-SE-2, Site 80-H-SW-4, and Site 113-H-W-4). Additionally, four (4) new schools were added to the list to be completed in 2022 (Site 30-E-SE-3, Site 90-K8-N-7, Site 132- M-W-4 and 89-E-W-4).

Dale Kelly reported one (1) month of Sales Tax collected for the current budget

year, which is just under \$23 million. Currently, the overall Sales Tax collection to-date is over \$3 billion.

#### Project Status Report

Mark O'Connor reported that there were budget adjustments for three (3) projects, including (1) Site 43-E-SE-2 was decreased by approximately \$2 million for deescalation savings resulting from the move of the opening date from 2023 to 2021, (2) Site 118-E-SW-2 was increased by approximately \$1.5 million for escalation costs resulting from the move of the opening date from 2020 to 2021, and (3) Site 113-H-W-4 was increased by approximately \$2.3 million to account for scope of work related to the addition of the proposed bus depot.

Craig Jackson reported that there are currently 17 projects under construction amounting to approximately \$412 million. He briefed the Committee on projects under construction, substantial completions, anticipated future milestones, projects in closeout and those in the design phase. He also presented various aerials for the projects that have achieved substantial completion.

#### > M/WBE Update

Aaron Smith presented the M/WBEs, LBDs and VBEs report for the fourth quarter of Fiscal Year 2019. He mentioned that there have been four (4) new certified LBDs.

#### Change Order Report

Ed Ames reported that since the last report, there have been various significant change orders, including, (1) the ODP reconciliation for Sally Ride Elementary School, (2) the reconciliation of CCD changes related to safety issues at Colonial High School, (3) various safety enhancement projects, and (4) the reconciliation of the CCD changes related to unforeseeable conditions at the Pine Hills Bus Depot.

Pat Knipe questioned the costs associated with redesigning Site 83-E-SE-E item #8 on page 41. Laura Kelly explained that the City of Orlando's approval was required for the site plan; however, the City was not supportive of the initial site plan and building orientation triggering the need for a redesign.

#### > Capital Renewal Update

Rory Salimbene reported there are 44 active projects currently in progress on 40 different sites. The total estimated cost for these 44 projects is approximately \$171.6 million and the total construction cost is approximately \$132.9 million. There are 11 projects in planning, 11 in design, and 22 projects under construction.

Rory Salimbene presented a new format of the Capital Renewal Report to the

Committee and asked if they would approve the new format going forward. The Committee voted on a motion to approve the new format and the motion passed.

#### **Presentation**

#### HVAC Presentation

Rory Salimbene provided an overview of the district's heating, ventilating and air conditioning (HVAC) approach and the methodology used to maintain the system via capital renewal. Tom Goodman provided an overview of commissioning and its role in ensuring efficient HVAC operation.

#### Lessons Learned

Basem Ghneim presented an overview of the lessons learned from the 2019 openings.

#### Community Update

Lauren Roth provided photos of the grand opening that was held at Boone HS and the sneak peeks that were held at six (6) new or renovated schools (Castleview ES, Deerwood ES, Horizon West MS, Pershing School, Water Spring ES and Colonial HS).

#### Construction Update as of October 10, 2019

We now have **13 projects** under varying degrees of construction amounting to approx. **\$424M.** 

#### 2 – Comprehensive = \$39,784,000

- Southwest MS (Comprehensive Renovation) NTP was issued on February 15, 2019, and involves five separate phases with an overall substantial completion scheduled for July 27, 2020.
  - Phase 1 separated into three sub-phases: the renovation of the (1A) chiller yard and replacement of chillers was substantially completed on August 30, 2019 and (1B) administration, gymnasium, cafeteria, and classroom building 900 were substantially completed on August 7, 2019, and (1C) classroom building 200 is scheduled to be completed by December 27, 2019.
  - Phase 2 separated into two sub-phases: (2A) the renovation of classroom building 300 is scheduled to be completed by July 27, 2020, and (2B) the renovation of Building 400 (Media), Building 500 (Art & Votech), and Building 600 (Music), along with remaining site elements are also scheduled to be substantially completed by July 27, 2020.
- Acceleration West (Comprehensive Renovation) Construction NTP is expected to be issued on October 11, 2019, and involves three separate phases, with an overall substantial completion scheduled for July 21, 2020.
  - Phase I includes the renovation of Building 100 (Administration), Building 300 (Classrooms) and Building 500 (Classrooms) and are scheduled to be substantially completed on February 24, 2020.
  - Phase 2 will account for the renovation of Building 400 (Media Center) and is scheduled to be substantially completed on May 22, 2020. This phase will also involve early access into building 200 (Cafeteria).
  - Phase 3 will complete the renovation of Building 200 (Cafeteria), along with the complete removal of all existing on-site portables, site utilities, and the re-grading of the site, and is scheduled to be completed by July 21, 2020.

#### And,

#### 11 - New/Replacements = \$384,308,000

Pine Hills Transportation Compound – a construction NTP was issued on September 21, 2017, for this Design-Build transportation project, with an overall project completion scheduled for November 2018. The project schedule accounted for multiple phases, with the Bus Parking and Staging areas to have been completed by March 8, 2018, the administration building to be substantially complete in August 2018, and the driver's lounge and parking, along with the maintenance building to be substantially completed in November 2018.

Due to unsuitable soil material discoveries, and the associated excavation and replacement thereof, the project experienced extensive time delays and resulted in the requests for additional compensation, whereby the Design-Builder reported a revised overall projected substantial completion date of August 30, 2019. Based on current progress and addressing issues with final inspections, a mid-late October 2019 completion is now being reported.

- Initial phase involving the Bus Parking and Staging areas was substantially completed on December 10, 2018, and the Administration Building was completed on January 8, 2019.
- The driver's Lounges and associated parking were completed on February 14, 2019.
- Based on claims issued by the Design-Builder, additional scope and cost associated with discovered unsuitable soils and debris were settled for just over \$1M.
- Separately, additional debris and loose soils were uncovered at the location for the new fueling island, for which has been addressed.
- Deerwood ES (Replacement) construction NTP was issued on June 1, 2018, and a main building substantial completion was achieved on June 11, 2019; and the subsequent existing building demo and related site amenities are scheduled for completion by October 15, 2019.
  - Due to challenges associated with play area rubberized surface suppliers, the team is anticipating a late October substantial completion date.
- **Boone HS Gymnasium** (Replacement)
  - Gymnasium a construction NTP was issued on July 23, 2019, with an overall substantial completion scheduled for July 7, 2020.
- Site 20-E-SW-4 (South I-Drive area ES relief) construction NTP was issued on May 17, 2019, with an overall substantial completion scheduled for April 10, 2020.
  - Due to delays associated with the issuance of the construction NTP and gopher tortoise relocation PO issuance, as well as, tortoise recipient site availability. A time extension of 33 calendar days has been granted, revising the substantial completion date to May 13, 2020.

- Pinar ES (Replacement/Renovation) construction NTP was issued on June 25, 2019, and the completion of the new main building is scheduled for substantial completion on April 3, 2020; and the subsequent existing building demo and related site amenities are scheduled for completion by October 2, 2020.
- **Rolling Hills ES** (Replacement/Renovation) construction NTP was issued on June 25, 2019, with an overall substantial completion scheduled for May 29, 2020.
  - Due to a late issuance of the NTP to the CM, a 10 day time extension has been requested by the CM, whereby the revised substantial completion date will be June 8, 2020.
- Site 83-E-SE-3 (SE Orlando/Lee Vista area ES relief) an early site package construction notice to proceed was issued on July 1, 2019, and an off-site retention pond and new building construction NTP was issued on August 14, 2019, with an overall substantial completion scheduled for June 25, 2020.
- Site 85-E-W-4 (Horizon West/Bridgewater Village South ES relief) construction NTP was issued on July 24, 2019, with an overall substantial completion scheduled for June 10, 2020.
  - Due to comments received from the County in regards to requirements for on-site vehicular queuing, along with optimizing the play area, a \$740,000 change order is being submitted to the Board late October. This issue will also extend the substantial completion date by 12 days, to June 22, 2020.
- Magnolia School and Behavior Center (New/Replacement) a construction notice to proceed was issued on July 3, 2019 for the overall project. The replacement building for the Magnolia School is scheduled for an overall substantial completion on June 8, 2020. And upon completion, the new Behavior Center building will commence with a scheduled completion on May 14, 2021. The balance of the site amenities, track and play courts, are then scheduled for an overall completion on July 23, 2021.
- Winegard ES (Replacement/Renovation) construction NTP was issued on July 2, 2019, with a main building substantial completion scheduled for June 1, 2020, existing classroom building limited renovation substantial completion scheduled for August 7, 2020, and an existing building demo and related site amenities substantial completion scheduled for November 13, 2020.
- Site 80-H-SW-4 (New Relief HS Dr. Phillips area) construction NTP of the early site package was issued on September 17, 2019. Substantial completion of the early package along with the main building package, once executed, will by May 14, 2021.
  - The main building package bidding exercise just concluded and is scheduled for a GMP submission by the CM late October 2019. The main building package has an anticipated NTP scheduled for mid-December 2019.

- Anticipated future milestones for construction:

#### Capital Renewal Update – October 23, 2019

There are 42 active projects (20 large, 17 intermediate, 5 small) currently in progress for improvements at 40 sites, with an estimated total cost of \$180.5M. This is a reduction of two projects since the last report. The total cost of active projects has increased by approximately \$9M, primarily due to increased estimated costs for several projects as described below. (These budget adjustments are not identified on the detailed report, as this is the first report in this format and this report is being used to establish the baseline budgets. Future detailed reports will identify budget adjustments from this baseline.)

9 projects are currently being planned, which is a decrease of two since the last report. Design commenced on an intermediate project addressing heating, ventilating and air conditioning (HVAC) improvements project at Wolf Lake Middle School, and digital curriculum requirements at Pinewood Elementary School were completed since the last report. The budget for the multi-site intermediate project combining roof replacement requirements at Windy Ridge K8 and Lakeview and College Park Middle Schools was increased to more accurately forecast the total requirement for the three sites. After adjustments, the estimated total cost of projects being planned is \$38.7M, which is a decrease of \$1.2M since the last report.

12 projects are currently in the design phase, which is an increase of one since the last report due to commencement of the design for the Wolf Lake Middle School project. Several projects in design are nearing construction commencement. We have finalized negotiations on Guaranteed Maximum Price (GMP) agreements on a roof and rooftop HVAC equipment replacement project at Acceleration East and a campus-wide project at Jones High School and anticipate construction commencement in October or early November. We are also negotiating a GMP proposal for softball field drainage renovations at Boone High School, and bids have been received for HVAC improvements at Freedom High School and a campus-wide project at Discovery Middle School. Construction on all of these projects will commence prior to the end of the year.

Design work continues on campus-wide requirements at Colonial 9<sup>th</sup> Grade Center, Ridgewood Park Elementary School paving requirements, HVAC and building envelope requirements at Bonneville and Riverdale Elementary Schools, and HVAC requirements at Lakeville Elementary School. Construction commencement for these projects and the previously mentioned Wolf Lake Middle School project is scheduled for 2020.

The total budget for projects in design is \$55.2M, which is an increase of \$8.5M due to the increase for the Jones High School project and the added project in the design phase. The budget for the Jones High School project was increased to reflect the final negotiated GMP, which was significantly higher than budgeted. The previous budget for the project was not revised to reflect the significant scope revisions that have occurred since the project was initiated in 2015. As this project now exceeds \$10M in construction costs, a detailed scope description is included with this report.

21 projects are currently under construction, which is a decrease of one since the last report. A small cooling tower refurbishment at Timber Creek High School was completed since the last report. No new projects commenced construction.

The 21 projects under construction include 8 large, 10 intermediate and 3 small projects, with an estimated total cost of \$86.6M and construction cost of \$65.5M. Estimated costs increased \$1.8M since the last report, with the majority of the increase resulting from the addition of radio communication improvements to the project scopes at Olympia and Timber Creek High Schools. Both of these campus-wide high school projects exceed \$10M in construction costs; a detailed scope description is included with the report.

Completion of the radio communication enhancements at Timber Creek High School will extend completion of the work at Timber Creek into early 2020. Projects at Olympia High School, Gotha Middle School, and Oakshire and Pinewood Elementary Schools are also scheduled for completion early in 2020; remaining projects currently under construction will be completed later in 2019.

The report forecasts a balance of unused capital renewal funds through the end of FY 2020 of approximately \$60M. This is a decrease of approximately \$3.5M since the last report, primarily due to the impact of the budget adjustments described herein.

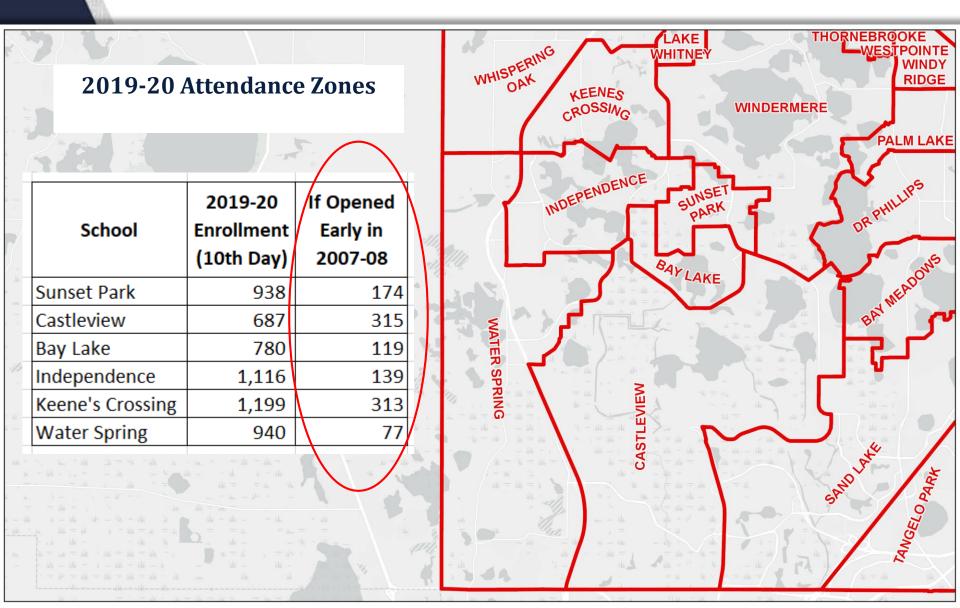

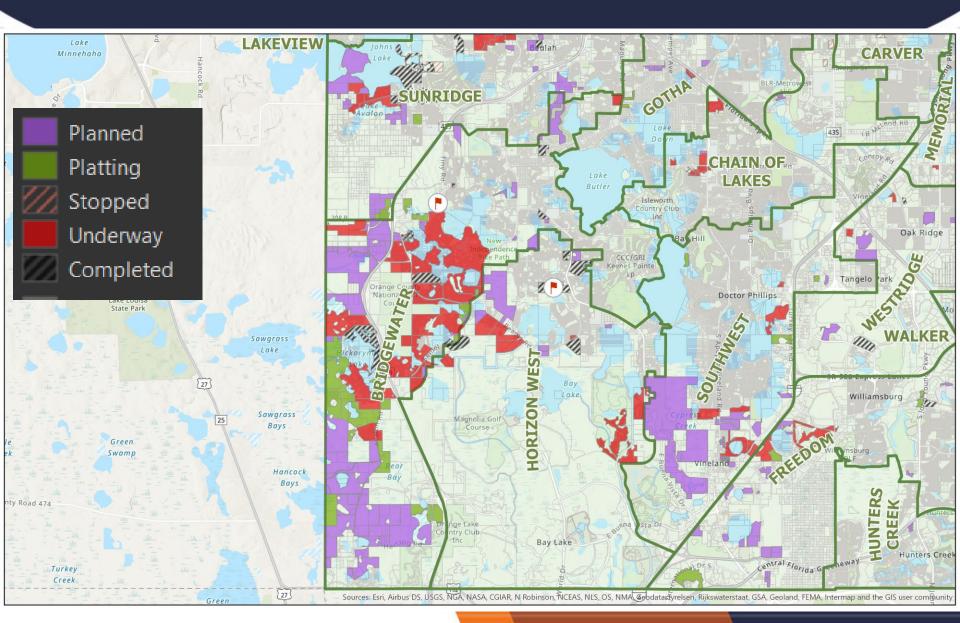
#### **Elementary Schools New 2020-21 Attendance Zones**



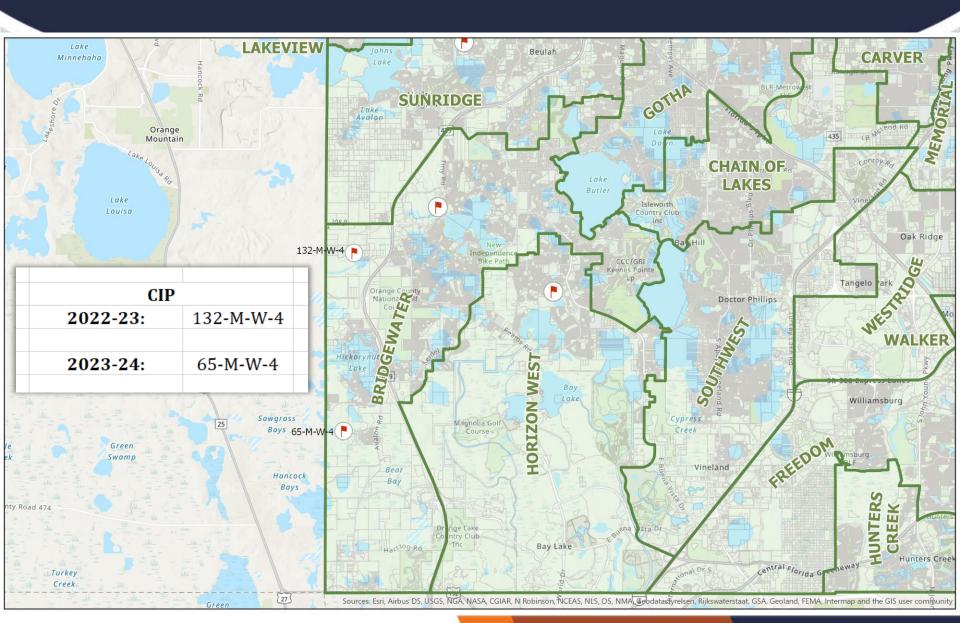
